Until today, it is believed that Raoul Wallenberg is still alive, unless proven otherwise, which is also the official view of the Swedish government. Being that President Clinton is meeting with President Yeltsin tomorrow in Moscow, we must fulfill our commitment to this great humanitarian and try to use this historic opportunity to discover his fate.

Therefore, as a last minute appeal, we feel that you could be of valuable assistance in requesting to President Clinton and President Yeitsin to mention Raoul's humanitarian rescue action in their messages to the media during this summit.

The latest reports are that the Swedish Prime Minister Carlsson brought the matter up with President Yeltsin. Please find the following quotation in the Prime Minister's recent letter to me, dated April 27th, he wrote

"Just a few days ago, at my meeting with President Yeltsin, I stressed the need to pursue the investigation further, with the hope of finding crucial evidence. We have already, on several occasions received assurances from Russian leaders that they will fully cooperate in these endeavours. I know that leaders of other countries, including the President of the United States and the Federal Chancellor of Germany, have also received such assurances."

To the best of my information, I haven't heard Raoul's name mentioned in ceremonies, held in London over the weekend, which was attended by many Heads of States, commemorating the 50th anniversary of the end of World War II.

From my letter to Knesset Member Esther Salmovitz, I would like to explain and clarify proposed question number 2:

"2) Will Israel Invite Raoul Wallenberg's co-worker, his half brother and half sister, and members of the Royal Swedish family to this meeting?" (Meeting of Ambassadors)

In the National Holocaust Remembrance Committee (CJC Memorandum) letter, dated May, 23, 1985, it states:

"Furthermore, Navon signed a proclamation granting the posthumous honor and awarding Honorary Citizenship to non-Jews who helped Jews flee and hide from German Persecution."

Additionally, in the letter from the Yad Vashem, dated August 9, 1985, it states:

"The Israeli Knesset declared all Gentiles Righteous as Honorary Citizens, provided that somebody initiate the request."

From the above quotes, as well as the enclosed correspondence, I understand that the Israeli Government does not distinguish between those good individuals who saved Jews. This sentiment was also expressed in the Yad Vashem's letter of December 1, 1991:

"With all sincere appreciation of the remarkable deeds of Raoul Wallenberg, which incidentally we acknowledged by bestowing upon him the honor of "Righteous among Nations", as well as awarding him Honorary Citizenship of Israel, there is no room to single him out among all the many others who risked their lives to save Jews."

I requested Honorary Israeli Citizenship for Raoul Wallenberg and Per Anger, as a reaffirmation of our gratitude, as Jews, for their great humanitarian rescue acts during World War II. I believe very strongly that the Jewish people and the State of Israel have a moral responsibility to search and uncover the true fate of Raoul. Regretfully, the Honorary Citizenship for Mr. Anger has yet to become a reality.

In both cases, I initiated this request (letter from the Canadian Jewish Congress, December 2, 1985, for Raoul, and the letter of the Raoul Wallenberg Honorary Citizen Committee, dated June, 23, 1994). The reason why I asked now that Per should receive the same honor, is that I felt this is one of our last opportunity to show gratitude to Per for his involvement with the rescue of Jews.

Therefore, with the help of Knesset Member Salmovitz, one of the proposed questions, as I stated earlier in this letter, will be to invite those closest to Raoul, as well as the Royal Family (the King of Sweden approved Raoul's mission), to Israel and a Knesset meeting, to show our gratitude for this great humanitarian rescue action. I believe that if such a visit became a reality, it would create a world-wide momentum for the search for Raoul. Therefore, it is hoped that this issue will become a priority on the Knesset's agenda in the coming months, and motivate other countries to become more involved.

I trust that this has clarified the reasons behind proposed question number 2.



This memo reflects the best of my recollections of the following meetings.

I share this information with all of you, as I feel that cooperation and unity is at this moment of vital importance in finding out the fate of Raoul. As I mentioned by personal conversation with some of you, it is important for me that you are able to advise me in case you feel I have made errors or have taken inappropriate actions for its only Raoul's fate which counts.

Next week there will begin a series of events throughout Germany and the Russian Federation, commemorating the end of World War II, it is important to realize that after this date, the interest in the events of the Second World War will diminish, it is therefore of deep humanitarian interest to get an answer on the fate of Raoul from President Yeltsin now.

From my observation, I see in the interest of the diplomatic corps and of the following countries, including Israel, the possibility of bringing the Ambassadors together within the next few months. On the other hand, I believe from their personal interest in this matter that quiet diplomacy is taking place in Israel, Germany, America, Canada and Sweden, in order to ensure that Raoul's fate is brought up in meetings between Prime Minister Rabin and President Clinton on May 7 and between Vice President Al Gore and President Yeltsin on May 8, as well as when President Clinton will meet with President Yeltsin on May 9.

I am therefore planning a press conference this Friday, May 5, which I hope to organize in conjunction with the Foreign Press Association in Israel, in order to call upon Heads of States, politicians and religious leaders and the peoples of the world to come out en masse so that Presidents Clinton and Yeltsin will make mention in their May 9th speeches about this great humanitarian rescue effort for Raoul. Although the ultimate purpose of this press conference is to encourage President Yeltsin to reveal the permanent truth on Monday.



Dear Mr. Grundberg,

Thank you for your letter of March 12 concerning Raoul Wallenberg. Your proposal has been given careful consideration. I can assure you that the Swedish government and I personally maintain a strong commitment to the search for the truth concerning the fate of Raoul Wallenberg. That is why a Swedish-Russian working group has now been active for 3 1/2 years. This group has also included American participants. That is also why we highly appreciate and support the contributions of others, both organizations and individuals, to this work.

Just a few days ago, at my meeting with President Yeltsin, I stressed the need to pursue the investigation further, with the hope of finding crucial evidence. We have already, on several occasions, received assurances from Russian leaders that they will fully cooperate in these endeavours.

I know that leaders of other countries, including the Prosident of the United States and the Federal Chancellor of Germany, have also received such assurances.

Dear Mr. Prime Minister Carleson:

As many countries are preparing themselves for ceremonies marking the end of World War Two, I am requesting your personal interferences in raising the negotiations for the whereabouts of Mr. Wallenberg to the level of Head of States.

In 1992, the then Swedish Prime Minister, Mr. Carl Bildt, declared on Mr. Wallenberg's Soth. birthday:

"On this day, however, there is also reason to consider the fate of Rapul Wallenberg, following his arrest by the Soviet military authorities in Budapest in January 1945. A Swedish-Russian commission is investigating what happened to Rapul Wallenberg. As long as the contrary has not been proved, we must assume that he may still be alive".

Last Thursday, March 9th 1995, I spoke to the Swedish Ambassador to Israel, H.E. Carl-Magnus Hyltenius, who informed me, that this Swedish viewpoint is still valid today.

May I therefore respectfully ask you to believe that for Racul Wallenberg the Second World War has not yet ended, until he is also able to live in freedom and peace.

51 years age it was decided to send Racul Wallenberg on a special mission to rescue the Jews people. And now 1 am requesting of you to try to save Racul.

In order to intensify the search for Raoul, I take the liberty to suggest that it would be of great assistance, if you were able to have a joint telephone summit, in order to explore the idea of appointing a special individual, who's task it would be to coordinate and extend the mandate of the Swedish-Russian commission. This person should have a diplomatic status and respected by all of your Excellencies. It is also important, that this individual has the finances available to search beyond the scope of the forementioned commission in order to find a final answer to the whereabouts of Raoul, before the world starts commemorating the 50th. anniversary of the end of World War Two in the beginning of May.

I appeal to you, as Head of States of democratic nations, to deal with this matter in an urgent matter, hopeful with the reward for you, to meet personally Rapul Wallenberg, who is considered the Human Rights hero of World War Two.
