DURING HIS TIME IN THE PRISON MAKINEN HAD SHARED CELL WITH THREE OTHER PRISONERS. THE FIRST HAD BEEN A PRISONER FROM THE UKRAINE DURING THE TIME JANUARY 15 TO MARCH 27 1962. THIS PRISONER WAS A BIT MORE THAN 30 YEARS OLD AND HAD BEEN IN PRISON SINCE 1948 AS POLITICAL PRISONER. HE CLAIMED THAT HE HAD NEVER BEFORE SHARED CELL WITH A FOREIGNER AND HE SPOKE VERY BAD ENGLISH. MAKINEN NEVER GOT INTO CLOSE CONTACT WITH THIS PRISONER, SINCE HE CONSIDERED THAT ONE HAD TO BE CAREFUL WITH SOVIET COPRISONERS. THE UKRAINIAN LEFT THE CELL TO BE BROUGHT TO A LABOR CAMP.

THE NEXT COPRISONER WAS KRUMICH, ABOUT WHOM MAKINEN HAD SPOKEN AT LENGTH ALREADY IN THE PREVIOUS CONVERSATION. KRUMICH HAD BEEN MOVED TO THE CELL ON MARCH 28 1962 AND LEFT IN ON JANUARY 29 1963 WHEN HE WAS RELEASED. HE HAD TOLD MAKINEN THAT HE INTENDED TO FETURN TO HIS HOME REGION, A SMALL VILLAGE 8-10 MILES FROM RIGA.

AS PREVIOUSLY STATED KRUMICH HAD TOLD MAKINEN THAT A SWEDE HAD BEEN IN THE WLADIMIR PRISON. ACCORDING TO KRUMICH'S ACCOUNT HE HAD GOT IN TOUCH WITH THIS SWEDE WHEN HE PREVIOUSLY HAD TO PERFORM CERTAIN CLEANING JOBS IN THE PRISON. KRUMICH NEVER TOLD WHEN THE MEETING WITH THE SWEDE OCCURED, BUT MAKINEN GOT THE IMPRESSION THAT IT WAS SEVERAL YEARS BEFOREHAND, AND THAT THE SWEDE NO LONGER WAS IN THE PRISON. MAKINEN HAD ALSO ASKED KRUMICH IF HE HAD EVER SHARED CELL WITH THE SWEDE, BUT KRUMICH DENIED THIS.

IN ADDITION TO WHAT MAKINEN HAD ALREADY TOLD PREVIOUSLY TO THE EMBASSY, HE COULD NOW ADD THAT HE MET A PRISCNER IN THE LABOR CAMP TO WHICH HE WAS BROUGHT AFTER HIS TIME IN THE WLADIMIR PRISON HEARING KRUMICH'S NAME, SAID THAT KRUMICH HAD SHARED CELL WITH A SWEDE IN WLADIMIR. HE HAD GOTTEN THIS INFORMATION FROM A POLE FROM THE UKRAINE.

IT MAY IN THE CONTEXT BE OF INTEREST THAT KRUMICH ALSO HAD SHARED CELL WITH THE U2-PILOT POWERS, AND THAT HE CAME DIRECTLY FROM POWER'S CELL TO MAKINEN'S. KRUMICH NEVER HID THIS FACT FOR MAKINEN, WHO AS WE KNOW HAD STRONG SUSPICIONS AGAINST HIS CELL MATE AND NEVER TRUSTED HIM.

AFTER KRUMICH HAD BEEN RELEASED ON JANUARY 29 1963 A MEMBER OF THE SECRET POLICE ASKED MAKINEN IF HE WANTED A NEW CELL MATE. HE ANSWERED THAT HE DID NOT MIND WHAT WAS DECIDED. THE POLICE THEN SAID THAT THEY WOULD TRY TO FIND A SUITABLE PERSON. TIME HAD THEN PASSED UNTIL THE END OF MAY WITHOUT HIM GETTING A NEW MATE. TO HIS SURPRISE THE ENGLISHMAN WYNNE MOVED INTO THE CELL ON MAY 29. MAKINEN AND WYNNE, WHO HAD JUST ARRIVED AT THE PRISON BECAME VERY GOOD FRIENDS AND ARE STILL IN SOME CONTACT BY CORRESPONDENCE. THEY HAD ALSO ONCE TALKED OVER THE TELEPHONE. WHEN WYNNE VISITED THE WEST INDIES. BUT HAD NEVER HAD THE OCCASION TO MEET.

WYNNE DID NOT UNDERSTAND RUSSIAN, AND AS FAR AS MAKINEN KNEW HE HAD NO CONTACTS WITH ANY OTHER PERSONS DURING THE TIME THEY SHARED CELL. THEY HAD OFTEN DISCUSSED OTHER FOREIGN COPRISONERS, AMONG WHICH THERE WERE TWO GERMANS AND TWO DUTCHMEN. THE GERMANS WERE TWO YOUNG STUDENTS FROM HEIDELBERG, PETER SONNTAG AND NAUMANN, AND THE DUTCHMEN PROBABLY WERE CALLED REYDON AND DE JAEGER. THE DUTCHMEN HAD BEEN LIBERATED AT THE END OF 1963 WHILE THE GERMANS PROBABLY ARE STILL IN THE SOVIET UNION, IN A LAEOR CAMP.

MAKINEN DID NOT DEFINITELY REMEMBER IF HE HAD TOLD WYNNE ABOUT THE SWEDISH PRISONER, BUT HE DID NOT EXCLUDE THAT HE COULD HAVE TOLD HIM

OF WHAT HE HAD HEARD FROM KRUMICH ABOUT THE SWEDISH PRISONER. BUT IT HAD NOT BEEN MUCH, THE ONLY THING KRUMICH HAD SAID WAS THAT THE SWEDE PROBABLY WAS PUNISHED FOR ESPIONNAGE, AND THAT HE ON SOME OCCASION HAD EXPRESSED A HOPE THAT WHEN HE ONCE RETURNED TO SWEDEN WOUL GET SOME SORT OF FINANCIAL CONTRIBUTION FOR HIS SERVICES, AND THAT HE ON SOME OCCASION HAD SHARED CELL WITH A FRENCHMAN.

ON AUGUST 9 MAKINEN HAD BEEN SEPARATED FROM WYNNE, AS HE WAS SENT TO A LABOR CAMP. A FEW MONTHS LATER HE WAS RELEASED. MAKINEN HAD READ THE NEWSPAPER ARTICLES OF WYNNE ABOUT HIS PRISON TERM. AND HAD NOTICED THAT HE HAD WRITTEN ABOUT A SWEDISH PRISONER AND THAT HE SEEMED TO KNOW MORE ABOUT THIS THAN WHAT HE COULD HAVE LEARNED FROM MAKINEN. MAKINEN THEREFORE ASSUMED THAT WYNNE HAD GOTTEN THESE FACTS FROM SOME LATER CELL MATE. MAKINEN COULD NOT REMEMBER ANYBODY BY THE NAME OF CHARLES.

MAKINEN REPORTED THAT THE HAIRCUTTERS OF THE PRISON OFTEN WERE GOOD SOURCES OF NEWS. KRUMICH ON HIS TIME HAD EXCELLENT RELATIONS WITH THEM AND CULTIVATED THEM BY GIVING HIS TOBACCO RATION TO THE HAIRCUTTERS. AFTER KRUMICH HAD LEFT THE PRISON MAKINEN CONTINUED WITH THIS. IN ORDER TO KEEP UP CONTACT WITH OTHER PEOPLE DURING THE TIME HE WAS ALONE IN HIS CELL. THE HAIRCUTTERS NOW AND THEN GAVE MAKINEN SOME INFORMATION ABOUT OTHER PRISONERS. BUT THEY HAD NEVER TOLD ABOUT A SWEDE, THE ONLY FOREIGNERS THEY TALKED ABOUT WERE THE GERMANS AND THE

TELEPHONE, WHEN WYNNE VISITED THE WEST INDIES, BUT HAD NEVER HAD THE OCCASION TO MEET.

WYNNE DID NOT UNDERSTAND RUSSIAN, AND AS FAR AS MAKINEN KNEW HE HAD NO CONTACTS WITH ANY OTHER PERSONS DURING THE TIME THEY SHARED CELL. THEY HAD OFTEN DISCUSSED OTHER FOREIGN COPRISONERS, AMONG WHICH THERE WERE TWO GERMANS AND TWO DUTCHMEN. THE GERMANS WERE TWO YOUNG STUDENTS FROM HEIDELBERG, PETER SONNTAG AND NAUMANN, AND THE DUTCHMEN PROBABLY WERE CALLED REYDON AND DE JAEGER. THE DUTCHMEN HAD BEEN LIBERATED AT THE END OF 1963 WHILE THE GERMANS PROBABLY ARE STILL IN THE SOVIET UNION, IN A LAEOR CAMP.

MAKINEN DID NOT DEFINITELY REMEMBER IF HE HAD TOLD WYNNE ABOUT THE SWEDISH PRISONER, BUT HE DID NOT EXCLUDE THAT HE COULD HAVE TOLD HIM

OF WHAT HE HAD HEARD FROM KRUMICH ABOUT THE SWEDISH PRISONER. BUT IT HAD NOT BEEN MUCH, THE ONLY THING KRUMICH HAD SAID WAS THAT THE SWEDE PROBABLY WAS PUNISHED FOR ESPIONNAGE, AND THAT HE ON SOME OCCASION HAD EXPRESSED A HOPE THAT WHEN HE ONCE RETURNED TO SWEDEN WOUL GET SOME SORT OF FINANCIAL CONTRIBUTION FOR HIS SERVICES, AND THAT HE ON SOME OCCASION HAD SHARED CELL WITH A FRENCHMAN.

ON AUGUST 9 MAKINEN HAD BEEN SEPARATED FROM WYNNE, AS HE WAS SENT TO A LABOR CAMP. A FEW MONTHS LATER HE WAS RELEASED. MAKINEN HAD READ THE NEWSPAPER ARTICLES OF WYNNE ABOUT HIS PRISON TERM. AND HAD NOTICED THAT HE HAD WRITTEN ABOUT A SWEDISH PRISONER AND THAT HE SEEMED TO KNOW MORE ABOUT THIS THAN WHAT HE COULD HAVE LEARNED FROM MAKINEN. MAKINEN THEREFORE ASSUMED THAT WYNNE HAD GOTTEN THESE FACTS FROM SOME LATER CELL MATE. MAKINEN COULD NOT REMEMBER ANYBODY BY THE NAME OF CHARLES.

MAKINEN REPORTED THAT THE HAIRCUTTERS OF THE PRISON OFTEN WERE GOOD SOURCES OF NEWS. KRUMICH ON HIS TIME HAD EXCELLENT RELATIONS WITH THEM AND CULTIVATED THEM BY GIVING HIS TOBACCO RATION TO THE HAIRCUTTERS. AFTER KRUMICH HAD LEFT THE PRISON MAKINEN CONTINUED WITH THIS. IN ORDER TO KEEP UP CONTACT WITH OTHER PEOPLE DURING THE TIME HE WAS ALONE IN HIS CELL. THE HAIRCUTTERS NOW AND THEN GAVE MAKINEN SOME INFORMATION ABOUT OTHER PRISONERS. BUT THEY HAD NEVER TOLD ABOUT A SWEDE, THE ONLY FOREIGNERS THEY TALKED ABOUT WERE THE GERMANS AND THE DUTCHMEN.

MAKINEN REMEMBERED AN EPISODE FROM A DAY IN MAY 1962. WHEN HE CAME TO THE HAIRCUTTER TO HAVE HIS HAIR CUT, THERE WAS SOMEBODY IN THE CABIN NEXT TO HIS. BEFORE MAKINEN WAS ALLOWED TO ENTER THE GUARD ENTERED TO THIS PERSON AND TOLD HIM NOT TO SAY ANYTHING AND GAVE A SIMILAR ORDER TO MAKINEN. HIS IMMEDIATE THOUGHT WAS THAT THE OTHER PERSON — WHOM HE NEVER SAW — MUST HAVE BEEN AN UNKNOWN FOREIGNER, A PERSON WHOSE EXISTENCE HE WAS SUPPOSED TO IGNORE. MAKINEN ADDED THAT HIS CWN RUSSIAN ACCENT WOULD HAVE DISCLOSED HIM AS AMERICAN FOR ANY DESERVANT LISTENER. NO CORRESPONDING SECURITY MEASURES WERE EVER TAKEN WHEN MAKINEN WAS CLOSE TO THE DUTCHMEN AND THE GERMANS, WITH WHOM HE COULD EVEN EXCHANGE SOME WORDS.

AT THE END OF THE CONVERSATION MAKINEN EXPRESSED HIS WILLINGNESS TO GIVE ANY INFORMATION ALSO IN THE FUTURE IN THIS MATTER.
